Hal : **Penerimaan Invoice/Tagihan Chevron Indonesia Melalui *Electronic Mail (E-Mail)* Periode Maret 2025**

Sehubungan dengan telah dihentikannya kebijakan Pemberlakuan Pembatasan Kegiatan Masyarakat (PPKM) terkaitantisipasi penyebaran COVID-19, maka dengan ini kami sampaikan bahwa Chevron Indonesia **tetap memberlakukan kebijakan penerimaan invoice melalui E-mail (IBUfinancelogger_202@chevron.com)** untuk periode **Maret 2025**, terhitung sejak tanggal **1 Maret 2025 sampai dengan 25 Maret 2025** sesuai dengan prosedur penerimaan invoice dalam memo-memo yang telah kami keluarkan sebelumnya (terlampir).

Hingga saat ini tim kami lebih banyak memproses dokumen *softcopy* daripada dokumen *hardcopy*. Oleh karena itu, kami mohon kerjasamanya untuk **mengirimkan faktur pajak asli melalui email, yaitu file Pdf faktur pajak yang di-generate langsung dari aplikasi e-Faktur**. Mohon untuk **mengirimkan softcopy invoice melalui email setidaknya pada hari yang sama pada saat hardcopy dikirimkan** untuk memperlancar proses pembayaran.

Lebih lanjut, sesuai dengan Undang-Undang No. 7 Tahun 2021 tentang Harmonisasi Peraturan Perpajakan (“UU HPP”), terdapat kenaikan tarif PPN dari **10% (sepuluh persen)** menjadi **11% (sebelas persen)** yang mulai berlaku pada tanggal 1 April 2022 dan **menjadi 12% (dua belas persen)** yang mulai berlaku paling lambat pada tanggal **1 Januari 2025**.

Berdasarkan PMK-131 Tahun 2024 untuk transaksi selain Barang Kena Pajak yang tergolong mewah berupa kendaraan bermotor dan selain kendaraan bermotor yang dikenai pajak penjualan atas barang mewah sesuai dengan ketentuan peraturan perundang-undangan di bidang perpajakan, dikenakan tarif PPN sebesar **12% (dua belas persen)** dengan **Dasar Pengenaan Pajak (DPP) berupa nilai lain**. Nilai lain yang dimaksud dihitung sebesar **11/12** dari nilai impor, harga jual, atau penggantian. Peraturan ini mulai berlaku pada tanggal 1 Januari 2025.

Lalu, kami juga kembali menghimbau kepada para rekanan agar pengiriman *hardcopy* dan dokumen pendukung lainnya dilakukan sebisa mungkin dengan menggunakan jasa PT Pos Indonesia. Hal ini dilakukan semata-mata untuk menghindari adanya kerumunan akibat antrian penyampaian dokumen oleh kurir demi keselamatan dan kesehatan kita bersama.

Demikian pemberitahuan di atas kami sampaikan, atas perhatian dan kerjasama seluruh rekanan, kami ucapkan terima kasih.

Subject : **Incoming Invoice/Billing Chevron Indonesia thru Electronic Mail (E-Mail) Period of March 2025**

In relation to government policy to lift the Emergency Restriction of Community Activity Policy to minimize the spread of Covid-19, We convey that Chevron will **continue procedure for the incoming invoice/billing submission through E-mail** (IBUfinancelogger_202@chevron.com) for period of **March 2025**, starting from **March 1st 2025 until March 25th 2025** in accordance with incoming invoice procedure (Memo) that we have issued previously (attached).

Currently our team mostly processing soft copy documents rather than hard copy documents. Therefore, we kindly ask for your cooperation to **submit original tax invoices by email, which the Pdf file of the tax invoice generated directly from e-Faktur application. Please send the softcopy through e-mail at least on the same day as the hardcopy sent to us.**

Furthermore, in accordance with the 2021 Harmonization of Tax Regulations Law No. 7 ("UU HPP"), value added tax (VAT) rate will be increased from **10% (ten percent)** to **11% (eleven percent)** effective April 1, 2022 and will increase to **12% (twelve percent)** starting efectively at the latest from **January 1, 2025**.

Based on PMK-131 of 2024 for transactions other than Taxable Goods classified as luxury goods in the form of motor vehicles and other than motor vehicles subject to luxury goods sales tax in accordance with the provisions of laws and regulations in the field of taxation, a VAT rate of **12% (twelve percent)** is imposed with a **Taxable Base (DPP) in the form of other values**. The **other values** referred to are calculated at **11/12** of the import value, selling price, or substitute. This regulation comes into effect on January 1, 2025.

Moreover, we urge partners to send hardcopy and other supporting documents using postal services. This is done solely to avoid crowds due to queues for document submission by couriers for the sake of our safety and health together.

Thus, the notification is informed, thank you for your attention and cooperation.
